On March 4, 2019, the TRSD Board of Directors acted to approve an application for a loan from RCAC to pay the TRSD engineering fees and costs associated with the application to USDA-RD; to complete the final plans and specifications for Phase I of the Work described in the TRSD Resolution of Intention No 18-004, adopted October 25, 2018; and to submit the plans and specifications to the ADEQ for approval. After the TRSD Board of Directors approved the RCAC Application, the TRSD staff noted several inconsistences and omissions from the Application. An amended application has been prepared by TRSD Staff and is on file with the TRSD Board which corrects and changes the application as follows:

A. The original motion referred to the engineer's pay schedule as a 21 month period. The motion under consideration by the TRSD Board corrects the RCAC Application to clarify that the pay schedule for such engineering will remain as stated at 21 months, but an additional three months has been added to complete the receipt of bids for Phase I and to award the Phase I construction contract;

- B. The form of the legal opinion to be rendered by Bond Counsel was not the most recent form. The most recent form has been filed with the TRSD Board; and

The TRSD General Counsel has redrafted and executed a new Loan Fund Assurance Statement to make clear TRSD's status as a municipal entity and not a non-profit corporation and the new Loan Fund Assurance Statement has been filed with the TRSD Board.
