- Item # 2. Financial Report Balance in the TRSD Account at the end of December, 2016. \$201,370.86
- Item #3. **Report by PACE on progress on amendments** to Phase 1 of the PER and discussion of preliminary cash flow projections has been given to L. Valdez, Financial Advisor. Cost comparisons were provided for Alternatives 2 and 3 over the 3 Phases. Board is asked to review the document electronically and respond as soon as possible. Map locations were reviewed and name changes elaborated.
- Item #4 **Update on communications with the Town of Miami Attorney** re Town of Miami reaction to inclusion of the statement regarding Miami Gardens in the TRSD response to the Attorney Sullivan letter on behalf of the Town of Miami. Direction to staff concerning the position of the TRSD regarding Miami Gardens since it is located within the boundaries of the DMA managed by TRSD. No action taken.
- Item #5 **Update on communications** with BHP re the Bechtel Tract wastewater treatment M.Krebs has had some communication with BHP, the District needs to get the insurance wrapped up, the Environmental Assessment completed and a financial statement. M.Krebs feels that a meeting with BHP and with ADEQ might be advantageous.
- Item # 6 **Update on Alternate Locations for a TRSD Wastewater Treatment Plant –** Additional information on currently available wastewater treatment plants which would be suitable for treatment of District wastewater and impact on capital costs of the project Discussion of alternate sources of funding: This item will be removed from future agendas.
- Item #7 Status of insurance coverage for access to perform cultural review at potential wastewater treatment sites and connecting lines – M.Krebs reported this has been done. Staff is pursuing general liability coverage quotes for the District – W.Clemmens is meeting with an Insurance agent on Wednesday and will obtain a quote.
- Item #8 **Report on Western Coalition of Arid States (Wescas)** funding for wastewater treatment projects under the Trump administration No additional information at this time although F.Rosenfeld's advice has been to expedite as much as possible the planning process in order to take advantage of any other available funding. A time-line has been developed for the process.

Report on Public Information for the TRSD Assessment District Process and schedule – A time line has been developed to prepare for the Assessment District Process that involves creating the information the public will need and a schedule of informational meetings leading up to the active Assessment District Process.
