President B. Zache called the meeting to order at 5:20 p.m.

- Item # 1. Minutes of January 5, 2015 Approved as sent by motion of M.A.Moreno, seconded by K,Kenney.
- Item # 2. Financial Report Balance as of December 31, 2014 \$ 138,399.87. Balance as of January 31, 2015 is \$137,404.60. Accepted by motion of K. Kenney, seconded by M.A.Moreno.
- Item # 3. **Status** of notarized statement to Chase Manhattan Bank as requested by Gila County has been submitted.
- Item # 4. Update on proposal from the City of Globe and Town of Miami re wastewater treatment -.Met with USDA, town of Miami, working with the Town to have wastewater treated as requested by USDA-RD
- Item # 5 **Report on meeting held at the offices of Leo Valdez** on February 5 in preparation for meeting with USDA-RD. B.Zache, Wm. Clemmens, M. Krebs, F.Rosenfeld and L. Valdez met with USDA-RD who strongly urged the District to work with the Town of Miami to treat the District's wastewater and further, to phase the project. The dilemma is that phasing will increase costs. F. Rosenfeld noted that the Assessment Process covers capital costs, not operating costs. He identified 2 ways to approach the problem have a separate assessment process for each phase OR do the entire assessment process up front but still phase the project.

USDA-RD really wants the District to contract with the Town of Miami for wastewater treatment in order to begin Phase 1. This will necessitate an election of the District electors.

L. Valdez suggested the assessment district process include the entire estimated cost of the project but that the District should have a 'letter of intention' from USDA regarding the amount of grant and loans from them.

Gilette regarding the hospital putting a line under Russel Gulch. The TRSD would like to see access provided at the time this line is constructed for a wastewater collection line for the District. M.A.Moreno moved that M. Krebs, District Engineer be instructed to work with Gila County and BHP on this matter, seconded by K. Kenney and carried.
