- Item #3. Report by PACE on progress on amendments to Phase 1 of the PER and discussion of availability of alternative funding The Amended PER has been submitted. M.Krebs spoke with M.Lueker at USDA-RD and his impression was that Mr. Lueker didn't have a problem with our alternate treatment plant. M.Krebs also reported that USDA had met with Gila Co. IDA and City of Globe. Mayor Gameros said that Globe is in support of the TRSD project. President Zache requested Legal Counsel communicate with the Gila County IDA that when TRSD is being discussed, TRSD should be notified and staff should be in attendance.

  Update on Alternate Locations for a TRSD Wastewater Treatment Plant Additional information on currently available wastewater treatment plants which would be suitable for treatment of District wastewater and impact on capital costs of the project –The technology of the proposed plant makes a significant difference to the costs in the PER.- No new information
