MEETING MINUTES

November 27, 2017

President Zache called the meeting to order at 5:17 p.m.

- Item #1 Minutes of October 23, 2017 Approved as sent by motion of M.Buzan, seconded byJ.Chism.
- Item # 2 Treasurer's report **Beginning balance \$193,409.20**, ending balance on 31 October -**\$222,733.15** M.A.Moreno moved the report be accepted and filed for review, seconded by J.Chism and carried.
- Item #3 Presentation and Letter of Support for the Watershed Project – Ashley Hullinger submitted several documents regarding the research she and her colleagues had done in the Globe-Miami area regarding local water resources. She is asking for support from the District as well as many other entities in the area to apply for a grant from the Bureau of Reclamation to create a "Watershed Partnership" for the communities that transcends political divisions to determine and develop strategies for water use and resources for future generations. The grant is for \$100,000 over 2 years and would most probably be utilized for a co-ordinator/director. Ms. Hullinger and the WRRC are looking for letters of support from stakeholders who are willing to work together for regional planning. The application is due by January 31 and Ms. Asbill-Case noted that these grants are competitive among 17 Western states so there is no guarantee of funding. Board member guestions included- how is the Partnership board selected? What would be the composition of this board? Ms. Hullinger noted that the members of the Partnership would need to make that decision and suggested the Graham-Greenlee Watershed Partnership could be a resource to answer some of those questions. She indicated she would transmit contact information of members of that group in order that the District Board can obtain more information. President Zache thanked her for her presentation and indicated the Board would discuss the requested Letter of Support.
- Item #4 Report by PACE on progress on amendments to Phase 1 of the PER submission to USDA-RD and possible timing for the issuance of a Letter of Conditions. Report on the meeting held with USDA-RD on November 14th R. Zache, W. Clemmens and M.Krebs met with Jeff Hays, Community Programs Director who indicated he would write a letter telling us the District would be receiving funding. The Letter of Conditions should be produced by March.
- Item # 5. **Update on communications** with BHP re the Bechtel Tract wastewater treatment. Status of draft proposed agreement setting forth the major terms for review by BHP; Non-disclosure agreement – BHP has signed the non-disclosure agreement.
- Item # 6 **Update on contacts** with City of Globe and Gila County re parcels of real property not included in the tax rolls for the TRSD List had been sent, Attorney Clemmens sent a letter to Sue Pontel asking for a meeting W.Clemmens met with the Assessor's entire staff. The AZ DOR needs to be involved and it is up to the District to contact them. The Assessor also noted that the District's boundaries aren't accurate. M. Krebs has been advised. Attorney Clemmens will report at the next meeting.
