Buzan. A notice was placed in the AZ SilverBelt regarding filling the vacancy, asking anyone interested to contact M. Harper, TRSD Attorney. Attorney Harper reported that no one had responded to date. The search will continue.

Item # 9 Response to Call to the Public questions raised at the 05/19/23 Board Meeting:

What is the site of the Water Treatment Plant? President R. Jacques stated that the District does not have a clear decision that he is able to speak about due to the Non-Disclosure Agreement. As soon as that is lifted, R. Jacques will schedule a Special Meeting to advise the public.

<u>How will the District deal with the Miami Town Council</u>? R. Jacques stated that the Miiami town counsel tabled the District's request for an updated letter of support of the WRF site. TRSD may revisit this issue once the location of the WRF site is announced to the public.

<u>Will Businesses and Residences be able to hook-up?</u> R. Jacques advised that, yes, both businesses and residences will be able to hook-up.

How much has TRSD paid PACE? R. Jacques answered that PACE has been paid \$3.5M.

What is the status of D. Buzan? R. Jacques answered that, as stated earlier in the Board Meeting, D. Buzan has resigned.

When is this project going to begin? Are there plans? R. Jacques advised that bidding should be done between the end of 2023 and the first quarter of 2024. Yes, there are construction plans that have been developed.

Has anyone given any thought to the fact that the streets are narrow and access will be difficult? R. Jacques advised that yes, we have given consideration to this.

What is the budgeted amount for the new TRSD staff position to work with PACE? R. Jacques advised that this individual would not be engaged until later in the fiscal year and this issue would be addressed then.
