- Item # 9 **Renewal of TRSD Insurance Policy:** R. Jacques reviewed the coverages provided and noted it would require review once construction of the WRF begins. The current policy expires June 5th of 2024. Coverages are the same as last year, with very little increase in premium. M.A. Moreno moved for payment, seconded by C. Calloway. Carried 5-0.
- Item # 10 **TRSD Proposed FY24/25 Budget:** R. Jacques explained the elements of the proposed Budget for 2025 and the overall impact on the District property owners. A. Vix provided significant information on several of the proposed budget segments and line items. M.A. Moreno moved to accept the proposed budget, seconded by M. Buzan. Carried, 5-0.
- Item #11 **TRSD FY24/25 Budget and its Impact on District Residents:** R. Jacques explained the impact of the proposed budget on a home with an assessed valuation of \$100,000 and compared that to the same effect over the past 2 years. He also stated the FY25 Budget and the tables showing the impact on District residents would be posted to the TRSD website by Friday May 24, 2024.
- Item #12 **Emerging Contaminants Grant Resolution:** T. Stratton explained the significance of Resolution 2024-003 that will authorize the application by the District for a WIFA loan (forgivable principal/grant) in an amount of \$1,436,000 for the Clean Water Emerging Contaminants Fund. M.A. Moreno moved to authorize the President to apply for this funding, seconded by C. Calloway. Carried, 5-0.
- Item #13 Interim Loan Resolution: Consider and possibly adopt Resolution 2024-004 that will approve an Interim Financing Agreement for Phase I of the Project in the amount of \$12,000,000. J. Lentz introduced himself as a representative of the financing organization. T. Stratton explained the 'draw down' nature of the financing and briefly explained the process USDA requires for these projects. M.A. Moreno moved to authorize the President to accept and sign Resolution 2024-004, seconded by M. Buzan. Carried, 5-0.
- Item #14 **Cloacina Change Order #1 WRF:** The change order will reduce the cost of the WRF Treatment Package. They are finishing their shop drawings. M.A. Moreno moved to approve Change Order #1, seconded by C. Asrarynezami. Carried, 5-0.
- Item #15 WIFA Pay Request #24: WIFA Pay Request #24 dated 3/31/2024 in the amount of \$42,256.05, which includes PACE's Pay Application # 29 dated 3/31/2024 in the amount of \$34,577.40. M.A. Moreno moved to approve Pay Request # 24, seconded by M. Buzan. Carried, 5-0.
